Old Business:

- Crown Underground ROW application 8946 Long Lake Road: Approved, fee of \$180, Supervisor Ostby will contact.
- Road Project Updates: The pre-construction meeting was held today. Estimated completion date is Oct. 1. Contracts were completed.
- Temporary Construction easements: there are five easements needed. Andrew Vistad will contact the property owners. Four permanent easements are still outstanding.
- There was an accident by Sunray Square on July 3. This required a helicopter landing and the road was closed for a length of time.
- Road Inspection: Horizon Hills, there is a spot where water sits.
 After road reconditioning, some crack filling should be done and the Long Acres area needs miro-blading. Micro-surfacing will cost an estimated 30,000.
 Crack filling should be done on 24th St, 18th St., 37th, 17th St 5th and 64th, 16th St, 57th and 59th, Horizon Hills. Supervisor Quale will investigate quotes for the crack filling.
 - A culvert needs to be replaced on 37th.
- 4 trees came down on Long Lake Road. The county removed one and will bill us. Supervisor Quale moved one out of the highway into the ditch and the property owner will be billed.

- Access Application received: Kyle Marks: Supervisor Peterson viewed and recommends approval. Supervisor Ostby moved to approve, Supervisor Quale seconded and motion carried.
- Flooding disaster estimates/requests: The township can submit a request for reimbursement for repairs to the 37th Ave. NE culvert.
