## PROJECT NOTICE

**RE:** 2025 Road Improvement Project

This notice is to inform you of the anticipated schedule for the upcoming full depth reclamation project and widening of Long Lake Road. Dovre Township has entered into an agreement with Duininck, Inc. to complete the work.

A pre-construction conference will be held July 7th with the Contractor to discuss the project and receive the schedule. They plan to begin the project with tree removals the week of July 7, followed by setting up traffic control and completing site preparation work the week of July 14th. Culvert replacement will start The week of July 21st. The road reclamation portion of the project will occur sometime between July 14th and July 25th, depending on the contractor's schedule and weather.

We will begin marking the removal limits, which mainly consists of removing driveway pavement and reclaiming the existing roadway pavement.

If you have underground sprinklers, electric dog fences, or other underground facilities within the Township right-of-way, please remove them from the Township right-of-way to prevent damage. A significant portion of the right of way will be disturbed. The rough right of way is 33 feet measured from the centerline of the roadway where platted or recorded. The Township will not repair sprinkler heads/systems, electric dog fences, or other such items if they are within the Township right-of-way and are damaged.

If you have underground facilities within your property that are close to the right-of-way, please mark them with flags to prevent damage. If you have a septic system that is close to the right-of-way, please notify us to avoid damage.

If you have flowers, bushes, fences, retaining block, landscaping rocks, or any other items within the Township right-of-way that are of significant value, please remove them from the Township right-of-way to prevent damage. The Contractor will be unable to work around these items. Anything remaining will be removed and disposed of.

During the project, it will be necessary to remove mailboxes as they will interfere with the road construction equipment. When removed, your mailbox assembly will be placed on your yard during construction to ensure that they do not get mixed up. If you would like to replace your mailbox post at this time, please purchase and assemble the post with your mailbox and place it near the location your old box was left. Once the project is complete, the Contractor will reinstall all mailboxes in accordance with United States Postal Service requirements.

During construction, the Contactor will be required to maintain the appropriate signage for the type of construction activity. The Contractor is also required to maintain local access to all residences through all phases of construction. However, please remain patient during the project as some inconveniences will be unavoidable. Portions of the road may have to be closed intermittently to facilitate construction. If special considerations are required for access due to disabilities, please let us know such that we will be able to work on a method to best assist you.

You may contact us with any concerns or comments throughout the construction project.
